Chris Madge welcomed everyone to the meeting and thanked them for attending.

1	Adoption of the Minutes of the last AGM	
	The minutes of the previous meeting were adopted unanimously, proposed	
	by Kevin Miller and seconded by David Savidge.	
2	Matters Arising	
	Any matters arising will be covered in the reports.	
3	Treasurers Report	
	Chris Richardson started by recording a big thank you to Derek for settling	
	him into the position.	
	He presented the annual accounts, up to the end of March 2024 and the	
	current cash position for the Trust. His report is attached.	
4	Annual Accounts Adoption	
	The accounts have been circulated prior to the meeting and are available on	
	the website. Adoption of the accounts was moved.	
	Proposed Chris ReesFitzPatrick	
	Seconded Paul Turner	
	Carried unanimously.	
5	Reappointment of the Registered Accountants – CA Plus	
	Our accountants this year have again been CA Plus. They are a not-for-	
	profit organisation and a charity, and they cost less than half of anyone else.	

	Chris Richardson proposed staying with them, seconded by Charlie Forbes	
	and carried unanimously.	
6	Chairman's Report	
	Chris gave a presentation covering what has happened over the past year.	
	This is attached.	
	Paul Turner added to the report by reminding us that Rotary were very	
	involved in setting up the project. The Trust's aim is to try and get ownership	
	of the whole route from various landowners. Recently the section from	
	Hopwell Road towards Breaston has been purchased from Sustrans and a	
	local farmer, including an important ransom strip which could have blighted	
	the entire project. He is negotiating with Sustrans for further sections	
	towards the Navigation pub in Breaston and emphasised the need to be	
	thinking about replacing trees and managing spoil.	
	Chris Madge also thanked the crews for their support with the riverboat, the	
	final outings will be this weekend then it will return to the winter moorings. Its	
	purpose is to make us visible in the city centre. We are doing a survey of	
	passengers and have received very positive comments.	
	Chris answered a question from the floor as to why the quote for moving the	
	sewer at Sandiacre Lock is so expensive (headline £450k). He explained	
	that we have taken out any work that our volunteers will be able to do	
	already, but we cannot get competitive quotes as work on large sewers near	
	water has to be undertaken by STW contractors under current legislation.	
	He is confident that we can reduce the headline cost, by "discussion". This	
	will start next week.	
	There was also a question about the Golden Mile at Draycott – it is not	
	possible to give a definite date for the work to be completed but we are in	
	talks with Network rail and Severn Trent. The former may deliver in 2026,	
	the latter would be after 2030.	
	It was noted that there may be an opportunity for donors who might be trying	
	to avoid the predicted increase in inheritance tax, but there is little time	
	before the planned budget. The directors will consider an approach to	Board
	legacies and inheritance tax avoidance over the next few months. Any	
	donation to a charity such as ourselves can avoid a liability to IHT. The Trust	
	has hired the fundraiser from Treetops for 4 days work on the pontoon	
	funding. She also has experience promoting legacy donations. We are now	
	looking to actively raise funds, and also thinking about corporate sponsors,	
	but these provide benefits over the longer term rather than for current	
	projects.	
7	Kate Birtles award	
	David Savidge outlined the tremendous support that the Trust had received	
	from Charlie Forbes in his constant support of the working parties,	
	transporting equipment and helping at events and even joining the forestry	
	team. The trophy was presented to him by Paul Birtles.	
8	Trust Priorities for 2025	
	Sandiacre – pushing for a start in the spring	
	Pontoon – pushing for installation in by March/April 2025, bureaucracy	
	permitting.	
	To keep working at Draycott, the Golden Mile, and clearing the land east of	
	Hopwell Road and the winding hole.	
	Appointment of Directors

	Val Clare and Mike Snaith. Kevin will speak to Val Clare.	
	Mike Snaith has offered himself for re-election.
